Be it enacted by the Oireachtas as follows:

Amendment of Housing Act 1988

1. The Housing Act 1988 is amended by inserting the following after section 10:

10

"Homeless persons and children

10A. Where—

- (a) a request for accommodation or other assistance is made to a housing authority by or on behalf of a homeless person, and
- (b) another person who normally resides, or who might reasonably be expected to reside, with the homeless person is a child,

the housing authority shall, when making a decision in relation to the request (including a decision about the provision of interim or urgent assistance)—

- (i) recognise the persons concerned as a family unit,
- 20
- (ii) regard the best interests of the child as a paramount consideration,
- (iii) have particular regard to the need by practical means to protect and assist families, including by providing them with safe accommodation, in order to support and encourage—

- (I) the effective functioning of families, and
- (II) the development, welfare and protection of children within a family home.".

2. (1) This Act may be cited as the Housing (Homeless Families) Act 2017.
